IMPORTANT NOTICE REGARDING BOOT-BINDING COMPATIBILITY

The information below is to inform retail and rental shops about possible compatibility issues between the variety of boots and bindings now available on the market.

Shops and customers can choose from a wide variety of ski/binding/boot systems for alpine and backcountry skiing. **Using ski boots and bindings that are not designed to be used together increases the risk of injury to the customer and increases the potential liability exposure for the shop.**

Using a properly adjusted ski/binding/boot system with components designed to be used together can provide a significant degree of protection, although it must be remembered that the forces generated by skiing are variable, and even the best system might not always retain when retention is desired, or release under potential injury-producing situations. **Using components not designed to be used together can increase the risk of unwanted release or retention and possible injury.**

Due to the large number of categories and varieties of products available, the compatibility of specific ski/binding/boot combinations can be difficult to assess without proper training. Ski/binding/boot compatibility means that a specific boot and specific binding are designed to work together, and they can provide the best skiing performance. Ski/boot/binding combinations from different categories should not be assumed compatible simply because they appear to fit with one another, and current shop test procedures might not be able to determine if specific skis/bindings/boots are compatible when combining equipment from different categories.

The following are recommended:

1. Unless the ski boot manufacturer and binding manufacturer state that the specific boot and binding are compatible, it is recommended that boots (e.g. Alpine, Alpine Touring, Walk-to-Ride, GripWalk) and bindings (e.g. Alpine, Walk-to-Ride, GripWalk, Multi-norm, AT, Tech) from different categories **not be combined for use.**
2. Prior to purchasing, renting, demoing, mounting, adjusting, testing, and/or servicing any boot and binding combination that is not explicitly identified as compatible by both boot and binding manufacturer(s), it is recommended that the shop **(1) inform the customer of the potential risks of using incompatible equipment, and (2) obtain a signed release statement from the customer indicating that they recognize, understand, acknowledge, and accept the increased risks associated with the use of incompatible equipment, and release the shop and all manufacturers and distributors of this equipment, as well as their owners, agents, employees and affiliates, from all responsibility and liability associated with the purchase, rental, demoing, installation,**

adjustment, testing, servicing and use of the equipment. It is recommended that you consult legal counsel for appropriate release language.

3. Determining boot/binding compatibility must be established first. If the ski boots and bindings are not from the same boot/binding system, check with the boot and binding manufacturer(s) to ensure compatibility. Shop testing devices (e.g. Vermont Safety Calibrators, Wintersteiger, Montana) are to be used to verify the release function of the compatible boot/binding system only (such as alpine boots in alpine bindings). Shop testing devices are not designed or to be used to verify compatibility of boots and bindings from different systems.

Example boot categories that are recommended for use only with specifically compatible bindings include, but are not limited to:

- Traditional alpine boots
- Walk-to-Ride boots
- Grip-Walk boots
- Alpine Touring boots

Example binding categories that are recommended for use only with specifically compatible boots include, but are not limited to:

- Traditional alpine bindings
- Walk-to-Ride bindings
- Grip-Walk bindings
- Multi-Norm Compatible (MNC) bindings
- Alpine Touring bindings
- Tech Bindings (that require compatible metal inserts in the boots)

RELEASE PREFERENCE

Determining Your Release Preference is Your Responsibility

Your Release Preference, height, weight, age, and boot sole length are used by the shop technician to determine the release/retention settings for your bindings. Consult these descriptions to select your Release Preference. This information may affect your risk of injury. Be sure to provide accurate information.

Skiers who designate themselves as (I) receive **lower than average ski binding release settings**. This corresponds to easier ski binding release in a fall. Recommended for entry-level skiers.

Skiers who designate themselves as (III) receive **higher than average ski binding release settings**. This designation is not recommended for skiers 47 lbs. (21 kg) and under.

If from experience, you have been dissatisfied with the release settings that result from your release preference, mention this to your binding technician.

Amer Sports binding indemnification applies to the 2024/2025 Retail Binding Line, Non-current Retail Binding Line and non-current Rental Binding Line models listed on the next pages. Indemnification does not apply to older non-indemnified binding models.

Non-Indemnified Bindings

Older models of bindings no longer on the Schedule of Indemnified Bindings may still be serviced, however **Liability Indemnification will not be offered by Amer Sports for these models of bindings.** Dealers wishing to service these models of bindings can reduce their liability risk by requiring an additional waiver and release agreement and attaching it to the Workshop Form. Such waivers should be reviewed by a dealer's own legal counsel to ensure compliance with applicable laws. Salomon, Atomic and Armada bindings are not designed or tested for use with **Monoboards**, therefore bindings mounted on Monoboards will not be indemnified.

AUTHORIZED DEALERS

Amer Sports offers liability indemnification to Authorized Dealers. Amer Sports will, to the extent, and within the limits that insurance coverage is available, defend and indemnify an Authorized Binding Dealer against liabilities from claims presented by any customer of the Authorized Dealer arising solely from the use of Salomon, Atomic or Armada bindings, provided:

- A. The dealer purchased the bindings from Amer Sports or one of its OEM partners.**

- B. The dealer has received written notice of a claim involving bindings.**
- C. The claim alleges use of the bindings resulted in injury.**
- D. All recommendation, procedures and policies in effect at the time of the incident were followed, including, but not limited to, those contained in the Shop Practices Manual, Technical Updates (if applicable), Purchaser Policies and General Terms & Conditions.**
- E. The Certified Technician is of legal age, defined as the "legal age to work," according to the laws of each state or province.**
- F. The dealer uses workshop and/or rental forms the same as, or equivalent to, Salomon/Atomic/Armada forms with currently approved Liability Release Language.**
- G. The dealer maintains proper and complete records for all bindings mounted and/or adjusted for a period of five years or the statute of limitations of the state or province, whichever is longer.**
- H. The dealer provides written documentation of the technician's employment or sponsorship, and training (e.g., method of training, proof of certification, etc.).**
- I. A copy of the properly completed workshop form or rental form, including a signed release, is submitted.**
- J. A properly completed Post Accident Ski Equipment Inspection Report, the same as or equivalent to the exemplary form displayed in the manual, is submitted.**
- K. Any other helpful information such as a Ski Patrol Incident Report Form is submitted.**
- L. The dealer provides Amer Sports with prompt notice of the claim.**
- M. The dealer fully cooperates in the investigation, litigation and/or settlement of the claim.**

- 3. Notify your insurance company. Amer Sports indemnification is not a substitute for liability insurance.**
